



House and Site Rules

of the Motorhome Park operated by the City of Recklinghausen on the Erlbruchpark P9 Car Park

1. Opening hours

The motorhome park is open all year round. Only in exceptional cases will the parking site be temporarily closed for events (e.g. Schützenfest, etc.) and briefly moved to Konrad-Adenauer-Platz.

2. Conditions of use

The designated parking site is exclusively available to mobile homes (German registration certificate II = "Sonder-Kfz. Wohnmobil"). The parking of caravans (trailer caravans, cars, motorcycles, coaches, sales trailers) and the erection of tents is not permitted on this site. Unauthorised parked vehicles will be removed at a charge. Camping (awnings etc.) is not permitted.

3. Registration, duration of use and fee

The usage fee of the motorhome park is regulated in the parking fee regulations of the City of Recklinghausen. The maximum usage period is 3 nights; the usage fee is EUR 8.00 per day/24 hours. Registration or reservation of a parking space is not necessary. It is not permitted to keep parking spaces free. There is a parking ticket machine at the parking site, where the fee can be paid by pressing the tariff button "Wohnmobil" (coin slot or card payment). If you stay for several days, the fee for additional days must be paid no later than 24 hours after purchasing the first ticket. The parking ticket must be clearly visible in the windscreen of the motorhome.

4. Equipment

The site has 6 motorhome pitches and a power pole with 4 slots for the power supply (EUR 0.50 per kWh).

A public WC facility is located within walking distance of the Dr.-Helene-Kuhlmann-Park. For the further supply of fresh water and disposal of faeces, the service station on the neighbouring Konrad Adenauer car park behind the railway underpass is available for a fee. Fresh water can be obtained by inserting a coin (EUR 0.10 for approx. 10 litres). A waste container for normal amounts of waste is available.

5. Fires

Open fires, barbecues etc. are not allowed on the motorhome park.

6. Consideration / Night rest

Town residents and other mobile home owners must be taken into consideration. Leaving the motorhome park by foot as well as arrivals and departures by car should take place without noise disturbance.

The night rest lasts from 10 pm to 6 am. During this time the noise level must be reduced to a low level.

7. Departure

The place must be left in a clean condition after use.

8. Order

All users must ensure order and cleanliness. All facilities and equipment must be handled with care.

9. Dogs

Dogs are allowed on the parking site, but must be kept on a lead. No additional fee will be charged. All "droppings" must be removed immediately by the owners. If necessary, please use the free bags provided near the park.

10. Liability

The user is liable to the City of Recklinghausen for all property damage and personal injury caused by the use of the motorhome park. He/she shall indemnify the city from any liability claims by third parties for damage arising in connection with the use of the motorhome park. The user waives his right to make liability claims against against the city and, in case of own claims, to assert recourse claims against the City of Recklinghausen.

11. Householder's right

The householder's right on the motorhome park is exercised by the City of Recklinghausen, represented by the control staff. Violations or non-payment of the daily fee can be punished as an administrative offence with a fine in accordance with the State Criminal Code and Ordinance Act. In addition, offenders may be banned from the premises. No claims for compensation or damages arise from this.
